Care Coordination provides professional geriatric care managers who assess seniors' needs for services, develop care plans, and maintain regular contact to lengthen the time seniors can remain at home and postpone placement into long term care or other options. Also, through care coordination, the organization's pool of volunteers offers regularly scheduled grocery shopping, pantry deliveries, friendly visiting, gardening and home repairs, assistance with transportation to medical appointments and other similar assistance to seniors.

Housing services provides assistance to seniors in need of affordable housing options including residential living social services and roommate placement services.

Seniors a go go provides escorted door-to-door transportation. The organization's drivers pick up members at their door, assist the member during their appointment or errand, and make sure they get home.
